MEMORANDUM OF ASSOCIATION

OF

"KUNAL EDUCATIONAL SOCIETY"

1. NAME OF SOCIETY:-

Name of the society shall be "KUNAL EDUCATIONAL SOCIETY".

2. REGISTERED OFFICE :-

The registered office of the society shall be situated at 1409, 14th Floor, Ansal Tower,
38, Nehru Place, New Delhi-110019.

3. WORKING AREA:- N.C.T. of Delhi

4. AIMS AND OBJECTS:-

The aims and objects of the society, for which the above society is established, shall
be as under:-

i) To spread education amongst the General Public.

ii) To open and develop educational Institutes from preparatory stage to Higher
Education including vocational and technical education Lab. Medical, Pharmaceutical
Nursing, Syphoyestropy etc.

iii) To open institutions for training in Fine Arts, viz. Music, Dance, Painting,
Photography etc and special courses such as Cutting-Tailoring and other special
subjects concerning for women.

iv) To provide facilities for working, poor and needy personnel on charitable basis.

v) To provide facilities for working women by opening Crèches, Work-Nursery and
other necessary school.

vi) To provide libraries and reading rooms to candidates members/students.

vii) To arrange and organize social, cultural and educational programmes, including
Satsang, Geeta Path and Jagran etc.

viii) To arrange and establish Balwadiies, Anganwadies and Centers for providing
training in Typing-Shorthand, Child-Preparatory Centers, Social Sciences
Languages and Physical Education.

ix) To provide education to uneducated adults and helpless children of the area.

x) To make representations with the Central and/or State Govt. for promotion and
advancement of the society.

xi) To publish books, charts, illustrations, periodicals, Fisheries and other publication
necessary to attainment of the aims and objects of the society.

- xii) To provide training for farmer in the field of agricultural Fisheries, Horticulture economic friendly areas.
- xiii) To open health centers for the child & women welfare.
- xiv) To organize seminar on justice, Educational and economical upliftment to raise legal demands and fundamental rights provided by the Constitution of India.
- xv) To organize seminar, meeting, press-conferences and other lawful gatherings from time to time.
- xvi) To take up effective, reasonable and lawful steps for the solution of the problems relating to the members of the society and/or relating to the General Public.
- xvii) To receive financial and non-financial assistance from Govt, Non Govt organization International Agencies, Banks and any other legal entity or individual.
- xviii) To accept donations, grants, presents, gift and other offerings in shape of moveable or immovable properties for the attainment of the aims and objects of the society.
- xix) To do all other things, acts, activities which are necessary and which may be incidental or conducive to the attainment of any of the objects of the society.
- xx) To acquire by purchase, take on lease, hire or by gift any moveable and immovable properties of any rights or privileges that may be deemed necessary or useful for the objects of the advance society.
- xxi) To enter into arrangements with and engage Management and Logistics companies to manage the affairs of the educational institutions established under the society.
- xxii) To grant such certificates or recognitions as the society may deem fit from time to time and to grant stipends, scholarships or any other assistance monetary or otherwise to the students or to the persons conducting research and development activities for the society.
- xxiii) To affiliate with Indian and foreign educational institutions and professors/teachers for the benefit of the student of the educational institutions set-up under the society in accordance with the laws and regulations prevalent.

All the income, earnings, moveable or immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects as set forth in the Memorandum of Society and no portion thereof shall be paid or transferred directly or indirectly or by way of dividends, bonus, profit to the present or past member of the society or to any person claiming through anyone or more of the present or past member except as compensation for hard work and actual performance of the activities of the society.
